The Road to Rounding Out

EDU's policy states a student may round out with any additional class(es) included within their program, even if it's not required for the specific beneficiary to graduate. Such classes must be specified by name in the approved program curriculum, and not previously completed.

Additionally, if the student has taken (or is enrolled in) every class offered as part of the program, the student may round out with classes not offered as a part of their program of education (i.e., any class offered by the educational institution).

Historical practice of "Rounding Out"

VA EDU published the Policy Advisory entitled "Revision of the VA Education Service Practice of Rounding Out". Policy effective Aug 1, 2021 "Rounding Out" courses certified are included within the program and count toward the student's graduation requirements

Section 4 of the REMOTE Act codifies VA practice of "rounding out"

If the student has taken every class offered as part of the program, the student may round out with any class

ractice of "rounding out" provides eligible GI Bill students in their last term with the option to take additional classes to their course load to full-time and receive a full-time monthly housing allowance. In accordance with law, VA authorized to pay GI Bill benefits for classes that are part of an approved program of education and count toward letion of that approved program of education.

ning on Aug. 1, 2021, students can "round out" in their last term only <u>if</u> they are taking classes that are approved for program of education. Classes approved for a program of education means those that can be used to satisfy the ation requirements of the program as specified in the curriculum. Classes that have been previously completed at be used to round out the student's course load.

tain full-time enrollment in their last term, they will be allowed to select from the other courses in that category.

To give an example, a student pursuing a degree in political science may have the choice to take two of four courses in government as a graduation requirement. If the student does not need a third or fourth government class for graduation but wants to round out, VA will allow the student to take those additional government courses because they are included in the student's program of education. Chosen classes <u>must</u> be specified by name in the curriculum.

The Post-9/11 GI Bill has been fundamentally transformed into a lifetime learning benefit allowing for remaining entitlement to be used in the future to obtain a higher level degree, train for a career change, stay abreast of changes within a vocational field, or obtain a related vocational certification or license.

We encourage students to work with their School Certifying Official to answer any questions they may have regarding Rounding Out and how they may use it during their last term. REVIEWING REPORT FEES FOR COMPLIANCE PROCESSES

- ECSSs, ELRs, and SAAs-Review how Reporting Fees paid to your school during compliance surveys
- Your School much document how you use Reporting Fees
- SCOs are required to have a separate account for these funds
- Documents include account number and what has been spent



COMPLIANCE IN REVIEWING ANNUAL REPORT FEES



- Surveyor will interview the primary SCO-Confirm how your school utilizes these funds
- Your document must show what you use these funds on
- If your school has 100 or VA studentssurveyor will interview the primary SCO
- Be sure not to spend these funds on unacceptable expenses

Reporting Fees | Allowed, Not Allowed



Allowed:

- VA Student Graduates (Tassels & Awards)
- New VA student orientations
- Hosting training event
- SCO conference, workshop



Non Allowed:

- Building Maintenance fees
- Fees and charges by the college within its own department providing services to all student
 - **Must be used on student veterans
- Off-setting payroll for SCO when duties are not 100% VA related
